

Antrim County Address Numbering Project

Antrim County Office of Emergency Management has created a program to assist property owners to comply with the county's Street and Road Numbering Ordinance. Antrim County property owners outside of the village limits* may obtain one address sign free of charge.

You can obtain a sign with your address number on it in 3 easy steps:

1st Step

Fill out an application found at the Antrim County Equalization Office or online www.antrimcounty.org

2nd Step

Mail the application to:
911 Address Sign

3rd Step

Property Owner may pick up completed sign at the Equalization Office - typically 14 days after the application is filed.

SIGN NEEDS TO BE 4 FEET ABOVE GROUND

All address signage needs to comply with the Antrim County's Street and Road Numbering Ordinance (specifically Section V B. 5 which reads):

A round or square wood post shall not exceed a maximum of four (4) inches in diameter, or a pipe post or any steel post shall not exceed a maximum of two inches in diameter, with two (2) pounds per foot maximum weight. The post shall be placed immediately adjacent to the driveway of the premises. The top of the sign shall be no less than four (4) feet above the ground. Such street or road numbers shall be placed on both sides of the post as to be plainly visible from road traffic lanes in either direction of travel.
